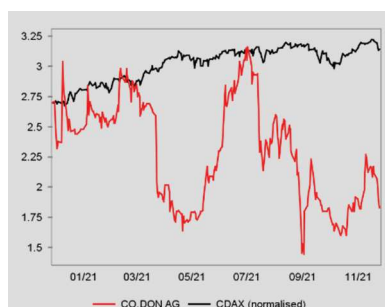

Asia licensing deal on the horizon; European expansion remains in focus

- Capital increase completed:** The company offered existing shareholders 4.9m shares at a ratio of 9:2 at a subscription price of EUR 1.30 between September 7 and 20. The listing of the new shares was completed on October 15. New shares not subscribed by the respective existing shareholders were taken over by CO.DON's principal shareholder Bauerfeind Beteiligungsgesellschaft (BBG). The capital measure yielded gross proceeds of EUR 6.3m, bringing the total share count to 26.72m. The proceeds will be used for general operations and European market expansion.
- Potential out-licensing deal for Asia:** while talking to the company, we got the impression that the deal negotiations with ReLive Biotechnologies are progressing as planned. ReLive would in-license the product from CO.DON for application in selected Asian markets (China, Hongkong, Macau, Singapore and Taiwan). Local doctors would explant the cartilage tissue, ship the sample to CO.DON in Germany where the tissue sample would be grown. Subsequently, local Asian doctors would reimplant the now grown cartilage tissue in Asia. A closing of the deal would yield milestone payments of EUR 2.75m to CO.DON with additional EUR 5.5m in milestones for a successful technology transfer. The high outside interest clearly confirms the attractiveness of CO.DON's cartilage repair technology.
- European market expansion is progressing as planned:** elective surgeries are being delayed across Europe because of the fourth wave of the Covid pandemic. The market in Switzerland saw the retreat of competition leading to increased demand for CO.DON's services. CO.DON expects the market launch of Spherox in Luxemburg (Q4 2021), France (Q1 2022), United Arab Emirates (Q4 2021) and Italy (H1 2022). In the short term, the company plans to expand the licensing business (see potential ReLive deal) and wants to develop its product portfolio with add-on products. In the long term, CO.DON plans to expand its portfolio with own development products.
- PT adjusted to EUR 4.20; Buy recommendation confirmed:** following an analyst change, we have thoroughly reworked our model.



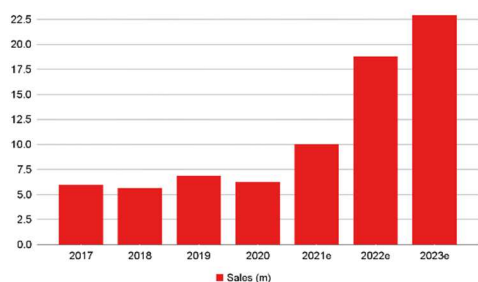

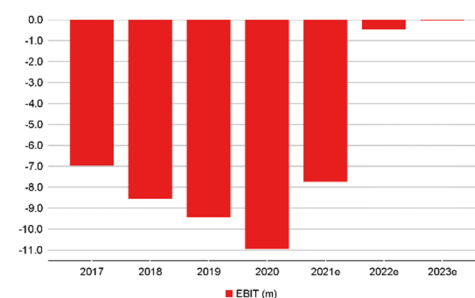

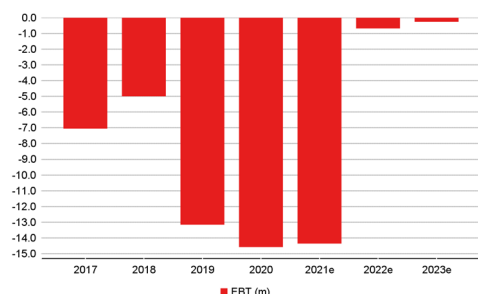
Company Background

- CO.DON AG is a manufacturer of autologous biopharmaceutical transplants. The Company is specialised in the treatment of articular cartilage defects.
- A transplant is created from the patient's own cartilage and own blood in the laboratory. The culture is then transplanted into the cartilage defect.
- The cell-based products are available in Germany since 2003 under a Paul Ehrlich Institute authorisation, with approx. 17,000 patients treated successfully.
- An EMA authorisation for a EU-wide distribution of the Company's product called Spherox, for the treatment of knee cartilage damage was obtained.

Competitive Quality

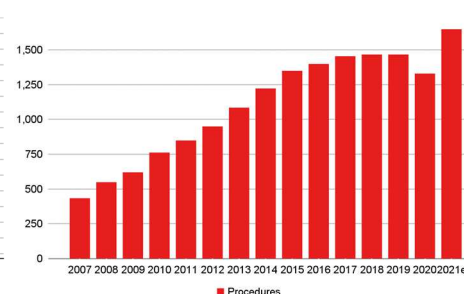
- With its joint-preserving product, CO.DON competes with manufacturers of surgical (i.e. metal) knee implants, which carry higher risk for the patients.
- A knee replacement procedure is considerably complex, while a cartilage replacement from CO.DON can be inserted by a minimally-invasive surgical procedure (arthroscopy). Costs for both procedures are comparable.
- Both procedures are covered by public health insurance in Germany. The CO.DON procedure is currently performed in more than 200 clinics and hospitals.
- As CO.DON chondrosphere is already in the market, CO.DON has a clear first mover advantage over new entrants.
- In light of the above 17,000 procedures that have already taken place and the confirmed effectiveness and safety of the procedure, the likelihood of strong demand in Europe is high.

in EUR m



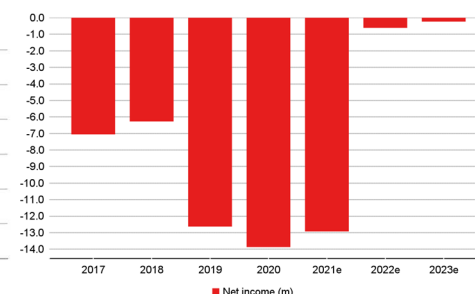

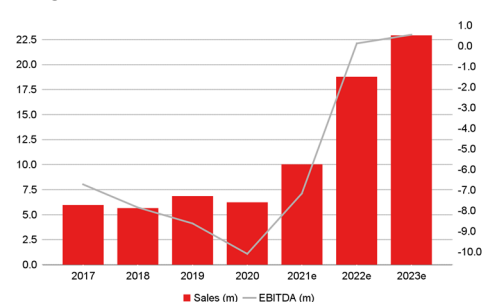

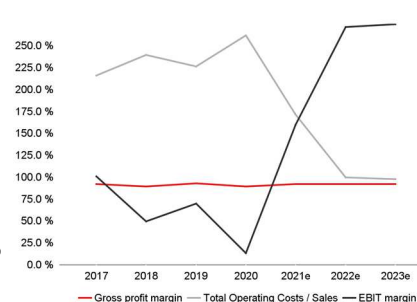

Sales, EBITDA in EUR m



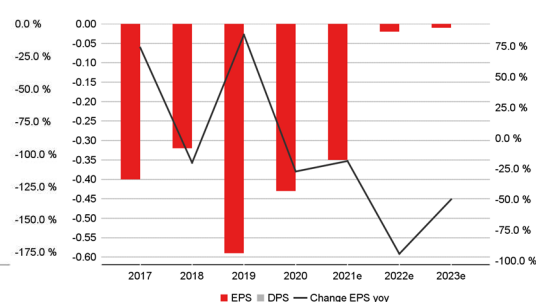

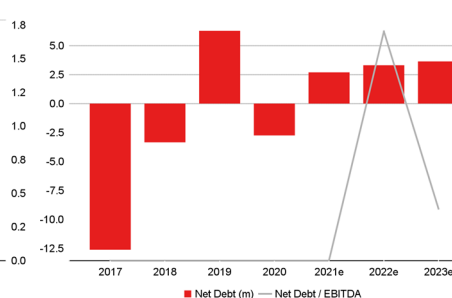

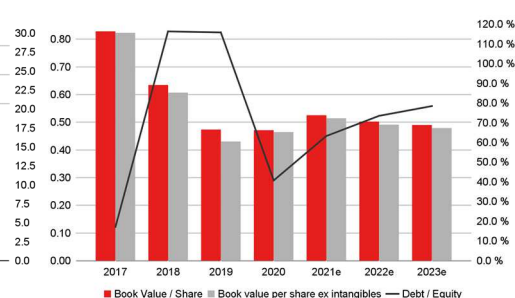
ROCE Development

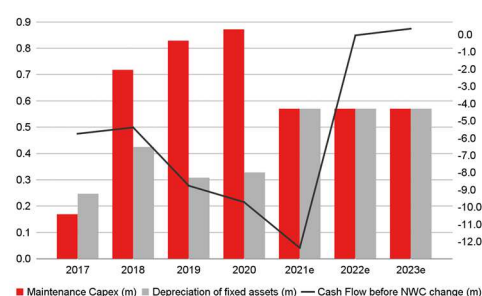

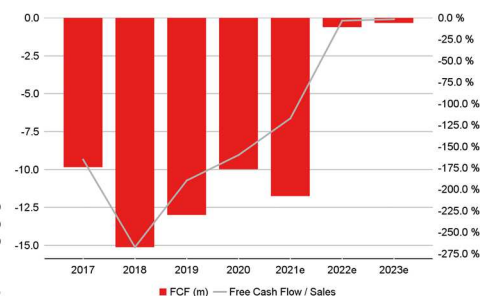
CAPEX and Cash Flow

in EUR m



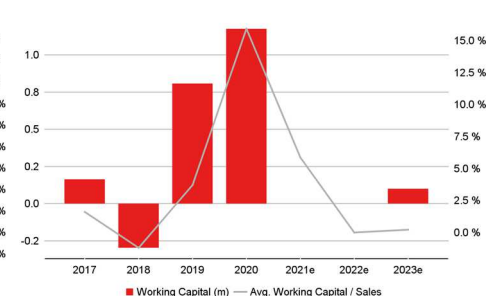
